Undertaking Terms & Conditions:

1. Responsibilities and Representations:

- a) I am aware that I am representing India, and I will make every effort to complete this training school to be held in Denmark in every aspect to raise the reputation of my country, my employer, CGC, and my family.
- b) I understand and acknowledge that CGC is not responsible for my actions, choices, and behavior, notwithstanding this:



- i. Alcohol shall not be consumed anywhere.
 - ii. Theft of any item from a hotel or hostel (including towels, pillows, blankets, etc.) and anything from the training centre or Denmark.
 - iii. No one who is not affiliated with the training program is allowed to enter my room/training premises. This includes, but is not limited to, persons I may meet during my stay.
- c) I agree to remain present at my assigned lab/training premises strictly according to CGC's time and venue schedule throughout CGC Fall School.
- d) I agree to complete the assignment the supervisor shall give in the timeframe devised.
- e) I agree that non-compliance with course attendance and coursework might result in not receiving the participation certificate.
- f) I agree to give my course photos and videos for CGC promotions & marketing on various platforms after the course completion.

2. Laws & Abiding: I will abide by all local, state, federal, or international laws and understand that any subsequent legal action can be taken against me. I want to mention that there are no criminal cases against me in India or abroad.

3. Medical Insurance & Consent: I agree to purchase and maintain personal medical insurance during the term and duration of the study abroad program that is applicable in Denmark. I further acknowledge and agree that I am responsible for the cost of any additional medical and health services which are not covered under my current insurance plan. I understand and agree that it is incumbent on me to purchase any further health care and travel assistance coverage that I might need for my study training program and subsequent travel. I certify that I have educated and informed myself about diseases, illnesses, and other health concerns resulting from living and traveling in a foreign country. I understand and agree that CGC assumes no responsibility for any damage or injury, including death, which might arise from or in connection with the provision or non-provision of any emergency medical treatment. I understand that CGC cannot guarantee my safety in Denmark.

4. Personal Belongings: I understand and acknowledge that CGC is not responsible for any loss of personal belongings or property I sustained during my training period in Denmark, including, but not limited to, credit cards, cash, luggage, and other personal items.



5. Travel & Stay:

- a) I will pay the visa charges to CGC and submit all the documents needed to apply for the visa by 20th Aug 2024. I understand that the Danish embassy can reject the visa and that the cost of the visa application and services will not be refunded.
- b) I declare that the documents we submit to apply for the visa are truthful.
- c) I confirm that I will be present during the allotted visa appointment at the convenient VFS Global centre.
- d) I will bear the cost of any transit from my accommodation to and from the training centre.
- e) I will pay the excess luggage charges, if any.
- f) I will carry sufficient funds in relevant currency (Danish Kroners) for any expenses during my travel and stay in Denmark.
- g) I am aware that the weekend (Saturday and Sunday) and evenings may be utilized for tourism or excursions, and I will bear all expenses incurred.
- h) I will bear food costs during my entire stay in Denmark.
- i) I will take the accommodation as booked by CGC and behave well throughout my stay. I will bear the accommodation cost.

OR

I will book the accommodation on my own and behave well throughout my stay. I will bear the accommodation cost.

- j) I will get my travel tickets done for India-Denmark-India from CGC. I will bear the travel cost.

OR

I will book my travel tickets to India-Denmark-India on my own. I will bear the travel cost.

- k) I will pay for any damage or breakage I caused during my stay in Denmark or at the training centre.

6. Payment & Finance Settlement:

- a) I agree to pay the course fee to the CGC bank account by 15th August 2024.
- b) At any stage, if I wish to cancel my travel to Denmark post the visa grant, I know that all the costs associated, including (but not limited to) course fee, visa, insurance, accommodation, airfare costs, etc, will not be refunded.
